1) Guests: Jason Marra, Cusack & Company

a) Presentation of 2012 Audited Financial Statements – Jason Marra explained the 2012 audit and answered questions from board members. He stated that DSIC had no area of concerns and was given a clean opinion, which is the highest rating a company can be given. Jim Salengo will request an accounting of the City's DSAD reserve account with the City of Schenectady's Finance Director.

We may work with the City's Foster Avenue garage on the project. EEM workers have been busy controlling weeds. Austin Fisher inquired about some type of automation to assist EEM workers with outdoor cleaning efforts.

A new workshop on Crime Prevention through Environmental Design will be scheduled for late July, which is based on a seminar held by the City. Two new businesses have just opened on Jay Street: Hermie's Music Store moved from the 700 block of State Street and Upstate Corals is a new saltwater aquarium shop.
