## 2. Board Committee Reports

a) Governance Committee: A meeting was set for May 15, 9-11am, to discuss potential candidates for three board seats. One-year term extensions for Heather Peterson and Austin Fisher were also discussed.

- c) Outdoor Program Committee: We purchased two new CFMOTO 600 Utility Vehicles for the maintenance program and one used golf cart for the landscaping program through our Metroplex equipment grant. Our electric vehicle is also back in service. Service work has been done on both the sweeper and vacuum vehicles; we are awaiting final parts for the vacuum. At their most recent meeting, the Metroplex board approved additional grant funds for equipment, as well as funding for Jay Square. Tim Fournier is training Josh Miller on his duties so we have leadership backup if Tim is out. He is also cross training team members on all equipment. It was suggested that we look at professional safety training for the bucket truck.
- **d)** Special Events Committee: Jim is meeting with the new branch manager of Pioneer about opportunities for getting involved with the DSIC. The Hometown Heroes banner unveiling ceremony is scheduled for May 23, 11 a.m., at the GE Theatre at Proctors.
